12104	Derangement of the knee, or their supporting structures
12105	Derangement of the ankle or their supporting structures
12106	Derangement of the shoulder or their supporting structures
12107	Derangement of the elbow or their supporting structures

Cardiovascular System For further investigation and monitoring of:

12120	Congenital heart disease
12121	Tumour of the heart or a great vessel
12122	Aortic dissection/aneurysm
12123	Abnormality of thoracic aorta
12124	Post operative aortic graft infection or dehiscence
12125	For further investigation, in persons under the age of 16 years, of the vasculature of limbs prior to limb or digit transfer surgery in congenital limb deficiency syndrome
6233	Cardiac magnetic resonance imaging (MRI) with or without contrast enhancement (Refer to attached rules)

Abdomen

12131	Characterisation of liver lesions when an ultrasound report is suggestive of haemangioma
12132	Detection and/or characterization of liver lesions
12133	Staging of abdominal masses where CT is inconclusive
12134	Evaluation of uterine fibroids, if Embolisation of uterine fibroids being contemplated, not in routine assessment for fibroids
12135	Staging of gynaecologic malignancies (endometrial, cervical and ovarian)
12136	Staging of rectal cancer
12137	Post operative recurrence of rectal cancer following CT and if tissue remains
12138	Staging of bladder cancer
12139	Detection of small pancreatic tumors not visible by CT, only if negative high resolution Triphasic CT scan of pancreas
12140	Assessment of fistulae/abscesses in patients with established Chron's disease following discussion with a multi-disciplinary team

Magnetic Resonance Cholangiopancreatography (MRCP) For further investigation of:

12160	Pancreatic and biliary disease where conventional methodology has failed
12161	and ERCP is considered undesirable

Magnetic Resonance Angiography (MRA) For exclusion or further investigation of:

12170	Stroke
12171	Carotid and vertebro-basilar disease
12172	Carotid or vertebral artery dissection
12173	Intracranial aneurysm
12174	Intracranial arteriovenous malformation
12175	Venous sinus thrombosis
12176	Vascular abnormality in a patient with a previous anaphylactic reaction to an iodinated contrast medium
12177	Obstruction of the superior vena cava, inferior vena cava or a major pelvic vein

For exclusion of:

12179	Renal artery stenosis post renal transplant
12180	Renal artery stenosis in patients less than 40 years of age with onset of significant hypertension and associated clinical laboratory or imaging evidence to suggest renal artery stenosis

12190	For investigation of transient ischaemic episodes, only following an inconclusive ultrasound (Note diagnostic use is not covered)

12200	Investigation of intermittent claudication or critical limb ischemia

Mesenteric

12220	Investigation of patients with suspected mesenteric angina, only following an inconclusive ultrasound (Note diagnostic use is not covered)

Aortic Arch

12230	Investigation of patients with transient ischaemic episodes / CVA or upper limb ishaemia.

12231	Investigation of patients with aneurysms, dissection , arteriovenous fistulae or coarctation

Magnetic Resonance Venography (MRV) For exclusion or further investigation of:

12240	Patients with suspected stenosis or occlusion of central veins.

12241	Patients with suspected thrombus in IVC or iliac veins, only following an inconclusive ultrasound

Body For further investigation and monitoring of:

12250	Malignant soft tissue tumours for diagnosis and staging
